Purchasing your Ghost Gunner 3 with our Layaway Plan is simple and incurs no additional cost. Your GG3 deposit[\$500] serves as your 'down payment' and the remaining balance [\$2000 plus \$120 shipping] can be paid in easy, interest-free payments. This agreement can extend out to 180 days or about 6 months and offers flexible payments to fit your budget.

# Layaway Agreement

- Up to 180 days or ~6mo

As with traditional Layaways, we can only ship if the balance is complete. Once the final payment has been made you will be placed on the build queue. Your machine will ship within 4 to 6 weeks upon completion of full term payments.

- 4. Get your spot on the build queue

# GHOST GUNNER 3 LAYAWAY AGREEMENT

Thank you for your interest in the Ghost Gunner 3 Layaway Program. To start the layaway, a \$500 deposit is required. Please note that this deposit is nonrefundable. We do not charge setup fees or interest for our layaway program. The length of our layaway plan is 180 days.

The expiration date of this contract will be clearly stated below. If the last day of the contract falls on a day that we are closed, this contract will be automatically extended through close of business of our next business day. If the contract is not fulfilled by the expiration date, the merchandise will be placed up for sale and all monies paid will be forfeited and are non-refundable. This contract cannot be extended.

We recommend regular payments, however, they are not required. During the 180-day contract period, you may make several smaller payments or one final payment at the end of 180 days.

Payments can be made using credit/debit cards, personal checks, business checks, money orders, and cashier's checks. Checks should be mailed to the address below.
